Poisoning symptoms:

Swallowing can result in nausea, vomiting and central nervous system depression. Small amounts of the solvent aspirated into the respiratory system during ingestion or from vomiting may cause bronchopneumonia, pulmonary edema and lung scarring. Skin contact with the solvent may have a degreasing action on the skin. Repeated or prolonged skin contact may lead to irritant contact dermatitis. Vapour concentrations above recommended exposure levels may be irritating to the eyes and respiratory tract. Inhalation of vapour may cause headaches, dizziness and possible nausea. Inhalation of high concentrations can produce central nervous system depression, which can lead to loss of coordination, impaired judgement and if exposure is prolonged, unconsciousness.

CHRONIC TOXICITY

Fluazifop-p butyl technical – results from animal tests indicated that repeated or prolonged exposure produced liver and kidney disorders and embryo/foetotoxic effects. Short term tests have shown that fluazifop-p is unlikely to be carcinogenic. The ADI (Acceptable Daily Intake) for humans is 0.003 mg/kg/day.

FIRST AID

Swallowed: Eye:	Rinse mouth with water. DO NOT induce vomiting. Seek immediate medical assistance. Irrigate with copious quantities of water for at least 15 minutes. Eyelids to be held open. Seek immediate medical assistance.
Skin:	Wash contaminated skin with plenty of soap and water. Remove contaminated clothing and wash before re-use. If irritation occurs seek medical advice.
Inhaled:	Move person to fresh air and keep at rest until recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have qualified person give oxygen through a face mask. If breathing has stopped apply artificial respiration at once. Exposure Potential - Swallowing is unlikely under normal conditions of usage. Significant skin uptake does not occur. Inhalation is a possible route of exposure. This product is diluted with water prior to use as a spray. This diluted form is less toxic by all routes of exposure.

Re-entry Period - Do not enter treated areas without protective clothing until spray has dried.

ENGINEERING CONTROLS

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Exposure Standards. Use with local exhaust ventilation or while wearing organic vapour respirator. Keep containers closed when not in use.

PERSONAL PROTECTION

May irritate the eyes and skin. Avoid contact with eyes and skin. When preparing spray and using the product wear elbow length PVC gloves and face shield. If product on skin, immediately wash area with soap and water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. SPILLS AND DISPOSAL

In case of spillage it is important to take all steps necessary to:

- Avoid eye and skin contact.
- Avoid contamination of waterways.
- Shut off all possible sources of ignition.

Procedure for spill:

- (1) Keep all bystanders away.
- (2) Wear full length clothing and PVC gloves.
- (3) Re-position any leaking containers so as to minimise further leakage.
- (4) Dam and absorb spill with an absorbent material (e.g. sand or soil).
- (5) Shovel the absorbed spill into drums.
- (6) Disposal of the absorbed material will depend upon the extent of the spill.
 - For quantities up to 50L of product bury in a secure landfill site.
 - For quantities greater than 50L seek advice from the manufacturer (use emergency contact number below) before attempting disposal. Contain in a secure location until disposal method is established.
- (7) Decontaminate the spill area with detergent and water and rinse with the smallest volume of water practicable.

Dispose of empty, used containers by:

- (a) Triple rinsing or preferably pressure rinsing containers with water. Add the rinsings to the spray tank. DO NOT dispose of undiluted chemicals on site.
- (b) If recycling, replace cap and return clean containers to recycler or designated collection point.
- (c) If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

Returnable containers:

- (a) Empty contents fully into application equipment.
- (b) Close all valves and return to a designated collection point.

FIRE/EXPLOSION HAZARD

This product is a combustible liquid. Keep fire-exposed containers cool by spraying with water. On burning will emit toxic fumes.
